At 1340 hrs on 2/19/04 a taped statement was taken from \_\_\_\_\_ who gave the following account of the incident. \_\_\_\_\_ stated that Pussieldi was \_\_\_\_\_ legal guardian between 2000 and 2002 and also one of \_\_\_\_\_ swim coaches at the swimming Hall of Fame. \_\_\_\_\_ advised that \_\_\_\_\_ and Pussieldi were involved in a physical confrontation at the Swimming Hall of Fame on 2/13/04. \_\_\_\_\_ stated that Pussieldi had pulled him out of the bleachers by a towel that was hanging around his neck ( See Case # 04-18791). \_\_\_\_\_ stated he would now like to report a videotape that he had located in Pussieldi's bedroom. \_\_\_\_\_ stated that on the tape he observed Pussieldi having sex with teenage boys. \_\_\_\_\_ stated that \_\_\_\_\_ thought they were teenagers because they did not have facial hair. \_\_\_\_\_ also stated that \_\_\_\_\_ did not think the video was made in the United States because \_\_\_\_\_ did not recognize the surroundings in the video and they were speaking Portuguese. \_\_\_\_\_ said that \_\_\_\_\_ saw three different boys on the tape, having sex with Pussieldi at different times. \_\_\_\_\_ also advised of a second videotape that showed him and his roommate \_\_\_\_\_ using the bathroom and getting undressed to take a shower. \_\_\_\_\_ stated that \_\_\_\_\_ did not know \_\_\_\_\_ was being filmed and it was done with a hidden camera, which \_\_\_\_\_ found in the bathroom in the air conditioning vent. \_\_\_\_\_ stated that \_\_\_\_\_ removed the batteries from the camera and scratched the lense so it would not work. \_\_\_\_\_ also stated that \_\_\_\_\_ had told \_\_\_\_\_ girlfriends parents (Ken Lucas) about the camera and they had confronted Pussieldi, and Pussieldi had admitted everything to them. **SEE STATEMENT FOR EXACT WORDING.**

On 3/22/04 I spoke with \_\_\_\_\_ by phone. \_\_\_\_\_ advised that when \_\_\_\_\_ was eighteen there was an incident between \_\_\_\_\_ and Pussieldi, were Pussieldi had touched \_\_\_\_\_ inappropriately. \_\_\_\_\_ told \_\_\_\_\_ that \_\_\_\_\_ did not want to pursue criminal charges when the incident had occurred. swimmers. He told several times to stop, but he would not. Pussieldi then asked him to leave the pool. again refused and started throwing things into the pool disrupting the other swimmers. Pussieldi then grabbed the towel around and pulled out of the bleachers. then left the facility without further incident. I asked Pussieldi if he was aware of the other allegations had made. stated yes he was. He stated that at no time were there cameras in his home, nor did he have any VCR tapes containing him having sex with other people. I asked why he thought had made these allegations. He stated that had lived with him and for approximately a year and half, and thinks that was jealous of the relationship that he and Martins had. Pussieldi stated that had told him that he would make sure that Pussieldi never coached again. I asked Pussieldi who is currently living with him. He stated that he has two swimmers living with him; the youngest is twenty-two years old. **SEE STATEMENT FOR EXACT WORDING.**

Based on this Detectives investigation and the statements given by the parties involved there is no evidence to prove the allegations. This case will be closed and cleared as unfounded.
